## APPLICATIONS

The Fair Office requests the following:

- Junior Livestock, Open show exhibitors and Commercial Exhibitors who need to utilize a motor vehicle to restock and/or maintain their livestock exhibits are required to purchase a vehicle pass from the Fair office to drive on the main fairgrounds.
- Applications MUST be filled out by EVERYONE requesting a Stock Gate Pass including; Board Members, exhibitors, concessionaires, vendors and carnival personnel.

## RULES AND RESPONSIBILITIES

Safety for everyone attending the Fair is a priority. PLEASE NOTE, the Stock Gate Pass covers on the driver and vehicle. It does not cover any passengers.

1. Drivers MUST be 16 years of age/have a current Drivers' License and be insured
2. ONLY the approved applicant driver (or specified adult driver) may drive vehicle with Stock Gate Pass. This DOES NOT include family members, grandchildren or friends, etc. of applicant
3. At All Times, approved vehicles must have the Stock Gate Pass Number displayed in the windshield while on the Fair Grounds
4. All approved Drivers MUST obey the speed limit as posted throughout Fair Grounds
5. Vehicles must be operated ONLY in approved areas as noted on the attached map
6. Vehicles will be permitted to enter the main fairgrounds between the hours of 6:30 am and 8:00 am for restocking their exhibits ONLY
7. **NO VEHICLE** will be allowed to enter and remain parked for the day. **ALL VEHICLES MUST BE REMOVED** from the main fairgrounds between 9:00 am and 11:00 pm. **ALL VEHICLES MUST BE REMOVED TO THE MAIN PARKING LOT.**
8. Vehicles may re-enter again after the close of the fair for restocking and maintaining their exhibits only
9. There will be **NO OVERNIGHT PARKING** inside the main fairgrounds area fairgrounds
10. Vehicles used for re-stocking on Midway must abide by designated times allowed per Fair Rules
11. THE VEHICLE PASS IS NOT FOR WALK IN ENTRY TO THE FAIRGROUNDS THROUGH THE MAIN GATE OR SERVICE GATES
12. Failure to abide by these rules will result in the following:
  - 1st offense~ a warning recorded in the Fair Office
  - 2nd offense - Non-compliance will result in the loss of the Stock Gate Pass for the remainder of the fair
  - The Fair Board reserves the right to revoke this Pass for any reason when deemed necessary
